# YOUR WILL

### **FUND INVESTMENT**

The GreaterGood capital funds are invested for income and capital growth through the security of the Public Trustee and Guardian's sector diversified Common Funds.

### **ESTABLISHMENT** COSTS

There are no legal or set-up costs when you give through the GreaterGood. Your entire gift will go to work immediately earning income for charitable causes.

- Friends of Greatergood Fund You may gift capital to the Friends of GreaterGood Fund to benefit worthy causes recommended annually by the board.
- Naming Rights Fund Individuals or family may set up their own named fund in GreaterGood to benefit charities or causes they nominate.
- **Corporate Workplace Giving Fund** Workplaces may set up their own named Workplace giving scheme to facilitate their workplace giving programme.
